- 5. **PAYMENT:** Upon completion of the website and review before the launch of website on your domain name, we will invoice you for the 50% remainder balance of the project. By contracting Roznik Media Enterprises to design a website you unconditionally and personally guarantee the payments.

Maintenance & Hosting Services that are 30 days past due and not paid are subject to termination or suspension. Payment made in full past the 30 day notice is subject to a \$150.00 reactivation fee. In case collection proves necessary, you agree to pay all fees (including all attorney's fees and court costs) incurred by that process.

6.
